Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

On October 26, 2021, the Board of Directors (the "Board) of Limoneira Company (the "Company") expanded the size of the Board to eleven directors and appointed Elizabeth Mora to serve as a Class III director, effective November 1, 2021. The Company filed a Current Report on Form 8-K on October 27, 2021 (the "Original Form 8-K") reporting, among other things, under Item 5.02 the appointment of Elizabeth Mora to the Board, and the information in the Original Form 8-K is hereby incorporated by reference in its entirety. At the time of the filing of the Original Form 8-K, Ms. Mora's committee assignments had not been determined. Effective January 25, 2022, the Board appointed Ms. Mora to serve as a member of the Audit and Finance Committee and Nominating and Corporate Governance Committee of the Board. Ms. Mora will serve as a director until the Annual Meeting of Stockholders to be held in 2023.
